### Cactus Reining Classic - March 18 - 22, 2020

NRHA Ancillary Category 1 \$10,000 Added Open Division will run concurrent with the [Cactus Reining Classic](#) Open Derby divisions, Saturday, March 21 at WestWorld of Scottsdale, Scottsdale, Arizona. This division is being offered as the final Million Dollar Competition Qualifier for The Run For A Million 2020. The top ten placings and ties will join the five riders who already qualified at the 2019 The Run For A Million Open Shootout, to compete for \$1,000,000 in prize money August 19 – 22, 2020 in Las Vegas, Nevada.

### 2020 MILLION DOLLAR COMPETITION QUALIFIER ENTRY REQUIREMENTS - ENTRY FEE

Make payments to The Run For A Million, Inc. Entry can be canceled at any time however entry fee payments, once made, are non-refundable. Riders can enter up to three entries, horses of any age, and horses used in qualifier are not required to be ridden in the Million Dollar Competition.
