



REGIONAL HOST EVENT APPLICATION ROOKIE AND NON PRO CHAMPIONSHIPS

TERMS AND CONDITIONS AGREEMENT

APPLICATION DEADLINE: 90 DAYS PRIOR TO THE FIRST DAY OF HOST EVENT COMPETITION

Qualifiers are being offered across the United States and Canada at regional NRHA approved events in 2020. The qualifying classes will run concurrent with NRHA Rookie Level 2 and NRHA Ancillary Non Pro divisions. Exhibitors are required to enter into the corresponding NRHA event divisions to be eligible for The Run For A Million (TRFAM) Qualifier. The top five placings, and ties in each slate, qualify to compete at The Run For A Million, August 19 – 22, 2020, Las Vegas, NV. Qualification is based on the rider, not the horse, only one time qualification required. See entry terms and conditions for complete entry details.

There is a separate entry fee for exhibitors for each qualifying division, per slate; \$200 for Rookie and \$200 for Non Pro. There are no prizes or added prize money offered and these qualifiers are not NRHA approved, but do fall under the same rules and regulations. The entry fees have been established to ensure those who are committed to wanting to take part in TRFAM Championships have the opportunity to do so without the possibility of being knocked out of a top five spot by another exhibitor who does not wish to, or cannot participate at TRFAM.

All qualifier entry fees must be paid to TRFAM by the host event within fifteen days after the last day of competition and include a complete list of all exhibitors entered in the qualifiers including their contact information. Late fees may apply after the fifteen day deadline.

Each approved host event will hang a minimum of two TRFAM banners, provided by TRFAM, Inc., in the main arena for the duration of the event. These banners must be returned to TRFAM within fifteen days after the completion of the host event, or host event may be charged a replacement fee. In addition, host events agree to promote TRFAM Corporate Sponsors by distributing print information and/or promotional products throughout the event, print information and products provided by TRFAM.

By agreeing to host TRFAM Championship qualifier, the event _____ (event or association name) to the fullest extent permitted by law shall defend, indemnify & hold harmless The Run For A Million Inc., Brumley Management Group LLC, its members, officers, agents and employees for and against any and all claims, damages, losses, expense and liabilities of every kind, including but not limited to attorney's fees, in any way arising out of or in connection with activities under this Agreement. This indemnity shall apply regardless of any active and/or passive negligent act or omission of The Run For A Million its members, directors, officers, agents, sponsors and employees. The Run For A Million Inc. and Brumley Management Group LLC reserve the right to cancel the event or change its features at any time without notice.

By submitting a host request application we further acknowledge that we have read and understand the Terms and Conditions to host The Run For A Million Rookie and Non Pro Championships Qualifier, and agree to the stated Release of Liability.
